The “small print”:

INSURANCE

Under law (as overseen by The Charity Commission) any activity run by a Charitable Group for the benefit of its members which involves any overnight hotel accommodation is deemed to be a “social event” and does not count as a “charitable activity”. Consequently neither the RSPB nor Lincoln RSPB Local Group provide any form of insurance or indemnity to cover personal injury or cancellation of your booking by you, or any unforeseen circumstances during the trip. As we use a reputable coach company for our travel you are covered under their insurance for the periods whilst you are “in transit” and under the care of their driver. We do however carry Public Liability insurance that covers Group members against 3rd party claims for damage that may be caused either by the Group, or an individual member.

You are therefore strongly recommended to make sure that you have suitable travel insurance that provides you with personal injury and cancellation cover.

REFUND POLICY

Deposits are non-refundable unless your place is re-sold or the event is cancelled, in which case a full refund will be made. Once the balance has been paid, refunds can only be made if the hotel makes a refund or we are able to book a replacement participant.

CANCELLATION BY LINCOLN RSPB

In the event that there are insufficient bookings to cover the costs of the holiday by the date on which the balance of the holiday price is due, Lincoln RSPB Local Group reserves the right to cancel the holiday and refund all monies paid.

PROCEEDS
